DJ Enterprises, Inc. provides professional bar service for all occasions. Our professional bartenders are licensed and insured.

The price of each bar package will include the bartending staff if the event is 100 guests or more. If the event is less than 100 guests, there will be bartender charges of \$20.00 per hour, per bartender.

The price of each bar package includes 1 bar location. If a second bar location is needed, there will be an additional \$100.00 set-up charge.

Each bar package includes plastic drink ware. Glassware may be added for an additional \$5.00 per person.

### **FULL SERVICE CASH BAR WITH HOST BEER AND SODA**

**\$7.95 per person**

**100 Guests or More**

**\$8.95 per person**

**Less than 100 Guests**

Hosted draft beer to include Miller Lite and Miller Genuine Draft. Coke, Diet Coke, Sprite, and Diet Sprite

Call brands of liquor and wine will be available to purchase from the bar.

The price **includes 6 hours of service**. Each additional hour of service will be charged at \$2.00 per hour, per guest for the hosted beer, soda, and staff.

### **FULL SERVICE CASH BAR WITH HOST BEER, WINE, AND SODA**

**\$11.95 per person**

**100 Guests or More**

**\$12.95 per person**

**Less than 100 Guests**

Hosted draft beer to include Miller Lite and Miller Genuine Draft. Coke, Diet Coke,  
Call brands of liquor and wine will be available to purchase from the bar.  
The price includes 6 hours of service. Each additional hour of service will be charged at \$3.00 per  
hour, per guest for the hosted beer, wine, soda, and staff.

### **HOSTED SODA BAR**

Includes unlimited Coke, Diet Coke, Sprite, Diet Sprite - **\$1.50 per person**

*(with a cash bar for cocktails, wine, and beer)*

**\$2.95 per person**

*(without a cash bar for cocktails, wine, and beer)*

Bartender labor will be charged from 1 hour prior to the event start time for set-up until 1 hour after  
the event end time for clean- up.

### **CASH BAR**

Call liquor, beer, wine, soda and bottled water will be sold for cash. If lemonade, punch and sweet tea  
are desired, it must be purchased by the gallon from the bar service not the caterer if it is only a cash  
bar for the event. The **bartenders will be charged at \$20.00 per hour**, per bartender. The client will  
be charged 1 hour prior to the event start time for set-up until 1 hour after the event end time for  
clean up.

### **1- HOUR HOSTED RAIL BAR**

**\$10.95 per person**

The package will include 1 hour of hosted mixed rail brand drinks, wine, Miller Genuine Draft and  
Miller Lite "on tap" and assorted soda and juice. In addition the tap beer and soda will remain hosted  
for an additional 5 hours. Each additional hour of bar time after the first 6 hours will be charged at  
\$2.00 per person, per hour for the hosted beer, soda, and staff.

**House:** brandy, whiskey, gin, vodka, rum, spiced rum, scotch, tequila, amaretto, and peach schnapps.

**House Wine:** Chardonnay, White Zinfandel, Merlot, Cabernet Sauvignon and Pinot Grigio

**Beer:** Miller Genuine Draft, Miller Lite, and Sharps

**Soda:** Coke, Diet Coke, Sprite, Diet Sprite

Mixers, ice, bar fruit, plastic drink ware, and cocktail napkins.

### **1-HOUR HOSTED PREMIUM BAR**

### **\$12.95 per person**

The package will include 1 hour of hosted mixed call brand drinks, wine, Miller Genuine Draft and Miller Lite "on tap" and assorted soda and juice. In addition the tap beer and soda will remain hosted for an additional 5 hours. Each additional hour of bar time after the first 6 hours will be charged at \$3.00 per person, per hour for the hosted beer, soda, and staff.

**Beer:** Miller Genuine Draft, Miller Lite, and Sharps

### **HOSTED BAR (additional hours)**

Hosted Rail Liquor - \$10.95 per person for the first hour plus \$3.00 for each additional hour.

Hosted Premium Liquor – \$12.95 per person for the first hour plus \$4.00 for each additional hour.

### **CHAMPAGNE**

\$2.75 per person

The price of the champagne will include the champagne glasses.

### **DINNER WINES**

Dinner wines are billed on consumption. A list of dinner wines will be provided upon request to compliment your meal. The price will include the wine glasses. There are 5 servings to a bottle. You may choose to serve 1 or 2 types of wine. The wines will be served table side.

### **POLICIES**

- A 50% deposit is required to contract the bar service for your event. The deposit and signed contract is due no less than 60 days prior to the event date.



- Events that are contracted less than 60 days out will be required to pay the 50% deposit within 10 days of receiving the contract.
- All events using a cash bar only or having a bar at the event but wishing to offer punch, lemonade, etc. must purchase these beverages through the bar service in order to have them at the event.
- A final guest count is required at least 10 days prior to the event date.
- The final bill will be subject to a 16% service charge and 6.1% sales tax.
- Final payment is required 5 days prior to the event date.
- Failure to submit payments within the time frame requested will result in cancellation of the bar service contract.
